At Terratinta Group SRL SB, aesthetic excellence, design and the innovation of our ceramic surfaces are intrinsically linked to our responsibility toward the environment and future generations. In line with our status as a Benefit Corporation (Società Benefit), we view the ecological transition not as a regulatory constraint, but as a core pillar of our strategic governance.

On May 27, 2026, the Board of Directors formally approved this **Climate Action Plan**.

This document represents our concrete commitment to mitigating both our direct and indirect climate impacts, contributing to the global effort to limit global warming to 1.5°C in accordance with the Paris Agreement.

This plan translates our vision into tangible, measurable, and time-bound targets, backed by targeted investments in human capital and technological innovation. We consider this document an open pact with all our stakeholders: only by joining forces with our value chain and our community can we transform workflows and protect tomorrow.

The review and updating of the Climate Action Plan are scheduled every 36 months.
